

PRESIDENT'S WORD
Mr. William F. Blick



It is with great pleasure that we introduce to you the first UOC annual report of our term of office. As we enter 2014 we plan to concentrate on our **strategic plan** that we evaluated in 2013 with our member federations and some other non-member federations under the IOC Solidarity program and support from the Ugandan and German governments. We have decided to focus on our core strengths and explore our exciting opportunities. This will enable us to exploit our competitive advantage to enable us to perform better at Olympic, Commonwealth and All Africa Games (both at senior and youth level).

Uganda has a huge human resource potential. We believe in **Human resource capacity building** as a way for developing our technical capacity to enhance greater and better performance of our athletes. Under the IOC Solidarity program we have already given opportunities to more than ten federations. In 2014 we will supplement this effort and ensure that all our federation administrators under take the IOC advanced sports management course run and managed by our own team. The UOC has also benefitted from the Canadian Commonwealth Games Federation Capacity support program. We will have a capacity support officer to help us with our operations.

The UOC will fully exploit its **strategic** partnerships with Russia, Germany, UK Sport (UK Athletics), South African Olympic Committee SASCO and Egyptian Olympic Committee to enhance our technical development. With these partnerships our athletes will receive greater expertise and exposure. In 2014 we will launch the first ever **National Olympic Committee** Medical Center in partnership with the Aga **Khan Foundation**. This state of the art sports medical facility will be based at the Metroplex Shopping Center in Ntinda along the northern bypass. The center will be part of the Aga Khan Foundation Medical hospital. We have already received an underwater massage unit from the German Embassy worth 40,000 Usd and expect more physiotherapy equipment to follow. We

have laid foundations to sign partnerships with the forces (Police, Prisons and Army) to guarantee employement for our elite athletes.

Sports Governance is a key operational strategy that we have already started to implement. We have enabled **Operational transparency** where our members have the right to access information through our website, annual report and from our offices. We have instituted successful council meetings quarterly with all our members and we plan to have an annual retreat to evaluate our performance and our strategic plan implementation progress. We have also introduced the bimonthly UOC newsletter that updates our members and general sporting fraternity. In 2013 we have made available the UOC offices and assets (Van, PA System, secretarial services, Tents chairs, Boardroom etc..) for federations to use for their meetings and AGMs. More than seventy percent of our members took advantage of this and we look forward to more members utilizing these facilities.

The **UOC commissions** are more active than they have ever been. We have managed to implement IOC programs from more than 80% of our commissions which have benefitted a cross section of the Ugandan sporting fraternity. In 2014 we plan to organize regional workshops with the Rowing and Swimming federations. Our Medical and Olympia Africa commissions will also hold regional seminars.

As you take time to read our 2013 report I would like to thank you for supporting the Uganda Olympic Committee and we look forward to partnering with you!



EXECUTIVE SUMMARY



The report provides information on the Uganda Olympic Committee, its mission, values and strategic objectives. The UOC is guided by the overall strategic objective that aims to, 'strengthen and develop the program management and resource mobilization capacities of UOC, in order to enhance implementation and long-term sustainability of UOC programs in Uganda.'

The key governance organs of the UOC are outlined and it is noted that the UOC council meetings have been reintroduced and the executive committee meets monthly. The UOC commissions are vibrant and active supported by the UOC secretariat.

The report provides an account of the activities of the UOC which include, the operations of the UOC secretariat, update on programs under the Olympic Solidarity program, interaction with member national federations/associations, collaboration linkages with strategic partners, international appointments, participation in international and regional conferences, preparation for various international games, anti-doping, strategic planning for the UOC, court cases update and award of the IOC 2013 trophy.

The report concludes by looking ahead to 2014 which is going to see Uganda take part in three major international games namely the African Youth Games (Gaborone Botswana), Commonwealth Games Glasgow Scotland and Youth Olympic Games (Nanjing China). The UOC in 2014 will focus on ensuring that its operations are run effectively and efficiently with the best interest of the athletes at the core of its ethos.

ABOUT UGANDA OLYMPIC COMMITTEE



The Ugandan Olympic Committee ("the UOC") is the National Olympic Committee recognized by the IOC pursuant to the Olympic Charter. Its membership is comprised of 20 affiliated members as indicated in annex 1. The UOC has the following organs:

The overall strategy decided upon by UOC that is to be adopted over the next three years is as follows: "To strengthen and develop the program management and resource mobilization capacities of UOC, in order to enhance implementation and long-term sustainability of UOC programs in Uganda"

The strategic objectives guiding the programming and implementation of the UOC programmes and whose results and effects, this report highlighted are:

Strategic objective 1: Athletes preparation and participation

- Prepare for the (A) Youth Olympics Games 2014 Nanjing China (B) Continental Games i.e. All Africa Games 2015, Youth African Games 2014 (C) Commonwealth Games Glasgow 2014 and RIO Olympic Games 2016.
- Mobilize resources for equipment, official kit, facilities

Strategic objective 2: Coaches development

- Technical courses for coaches
- Olympic scholarships.

Strategic objective 3: Promotion of Olympic Values

- Supporting the activities of the relevant commission i.e. Sports for All, Women and Sports, Sports medicine, environmental sustainability in sports.
- Participate in relevant national, regional and international conferences/fora





Strategic objective 4: Strengthen sport administration

- Conduct sport administrators courses for UOC executive committee and officials from National Federations.
- Train additional National Sports Directors

Strategic objective 5: To strengthen the UOC Secretariat operations

- Undertake an organizational assessment and develop an appropriate organogram for the Secretariat and respective job descriptions
- Undertake recruitment for human resources with respect to the new organogram
- Develop internal operational policies (Financial, People/Human Resources, Resource mobilization / fundraising, Technical sports policy, Board Constitution, etc.)
- Develop a Marketing and Promotion strategy to include public relations and communications policies and structures
- Provide training to UOC Secretariat staff and the executive committee for strengthened operations
- Secure a permanent home for the UOC

Strategic objective 6: Achieve financial sustainability for UOC operations and program activities

- Develop a fully costed budget for the 3 year strategic plan, and annual operational plans (2014, 2015 and 2016)
- Develop concept documents and proposals on a consistent basis for submission to Olymic Solidarity and other potential funders (Note: this would have to take into consideration the funding cycles for different sponsors)
- Secure funding for program management and administrative activities
- Develop a fundraising strategy and action plan (in-kind vs. financial support, customized pitches to individuals, corporates etc; use of social media, etc). To include income sustainability program (merchandizing: T-shirts)
- Lobby Government Ministries and Parliament with the intention of securing long-term sustainable funding within annual budgets

5. Adoption Of UOC 2013 Constitution

On 9th March 2013, the 2013 Constitution was formally approved and adopted during an Extra-Ordinary General Assembly held on 2 February 2013. This was the culmination of the highly participatory Constitutional review process that commenced in 2011. The IOC also approved the Constitution which is presently in force. One of the key features of the new Constitution was the introduction of two five year term limits for the holder office of the President. UOC also re-branded itself with a new logo.

6. UOC General Assembly

The 2012 Annual General Assembly meeting was held on 9th March 2013 at which the new executive committee was elected. In addition the UOC 2013 Constitution was adopted and is currently in force.

7. UOC Council Meetings

During the reporting period council meetings were introduced. 2 council meetings were held in the year and these have proved to be vital forums for information sharing between the UOC and its members.

8. Induction of the New UOC Executive Committee

Following the election of the new Uganda Olympic Committee Executive Committee on 6th March 2013, an induction session was held on April 6th 2013 at the UOC offices. The induction was attended

The following objectives underpinned the holding of the induction session;

- 3. To acquaint the new members of the UOC Executive Committee with the draft UOC Strategic plan
- 4. To provide the new members of the UOC Executive Committee with the history and background to the IOC and Olympic movement and;
- 5. To acquaint members on the roles and mandate of chef de missions

9. Membership

The current UOC membership stands at twenty (20) member association/federations. Of particular note was the resolution of the long running wrangles within the Uganda Boxing Federation with the election of a new executive committee under the leadership of Mr Kenneth Gimungu. We would like to thank the entire team at AIBA, the normalization committee under the stewardship of Mr. Denis Galabuzi and Mr. Moses Mwase for their tireless efforts in supporting the successful resolution of the UBF situation. This indeed marks a seminal moment for the UBF and we look forward to Uganda Boxing rising up from the ashes like a phoenix and doing Uganda proud. There has been effort by some sports federation to affiliate but were yet to meet the minimum requirement for them to be recommended for inclusion in the UOC family as members.

10. UOC Secretariat

A. Secretariat operations

The secretariat remains operational and weekly meetings continued to be held. The 5 interns that have been assisting the secretariat concluded their assignment. They assisted in some of the activities of the secretariat.

B. The UOC accountant Ms. Julie Acom resigned from office following involvement in misappropriation of funds. She is currently subject to disciplinary procedures and the matter is being further investigated by the UOC legal commission and disciplinary panel.

C. Ag. Administrator study leave

The acting administrator Mr. Collins Ssemanda is away on study leave until June 2014 pursing a Master in Sports Administration. Mr. Eljah Nawuzi is acting administrator until Collins return.

D. Staff contracts

Staff contracts have concluded. Staff remunerations and benefits are being reviewed.

E. Capacity Support Officer from the Commonwealth Federation

Our application for a capacity support officer from the Commonwealth Federation was approved, UOC has the task of fulfilling the requirements of this officer to include availing him/her a laptop and an office. The CSP is expected in January 2014.

c. UOC commissions

Several of the commissions have been active. For example the Sports All Commission organized Olympic day activities in July. UOC visited on the 6th July 2013 to Francis Nyangweso Olympafrica Center in Busia to handover equipment that was donated by the International Olympic Committee. The legal and ethics commission provided legal advice and guidance on several UOC legal related matters. The medical / environment / women for all / media / and culture and education commissions all carried out a number of activities during the year.

d. Interaction with national federations/associations

We were able to attend a number of activities organized by various national federations/associations. These included events organized by Uganda Volley Federation, Uganda Lawn Tennis Association, Uganda Archery Association, Uganda Swimming Federation, Uganda Hockey Association and Uganda Ruby Union. Through these interactions we were able to see firsthand the operations of





these federations/associations. Federations/Associations are encouraged to invite the UOC executive committee to attend and also attend activities of other federations/associations.

e. UOC communication

The UOC website has been modified and improved and is the key gateway to the outside for us. Furthermore UOC published its newsletter highlighting key events carried out in 2013. In addition the UOC secretariat has sent regular updates and communication via email to all its members. Going forward we intend to continue using this e-platform as the main means of interfacing with our members.

12. Collaborative Links

Over the last 12 months we have initiated collaborative links with a number of strategic partners and these include (1) Aga Khan Hospital and Foundation (2) UK Sport (3) World Athletes Foundation. In addition we are following up with (1) Russian Olympic Committee – MoU signed (2) South African Olympic Committee – MoU pending (3) Egyptian Olympic Committee – MoU pending (4) Generations for Peace Institute – contact initiated (5) German Olympic Committee (DOSB) - MoU signed (6) Mentor International - MoU concluded . It is envisaged that these collaborative links with assist UOC and its members enhance the capacity of the athletes. We held a dinner with the new NCS board as part of building partnership on 7th November 2013.

13. Meetings With the Inter Ministerial Task Force Developing the Statutory Instruments Vis The National Council Of Sports Act 1964

We held a meeting with the inter-ministerial task force developing the statutory instrument in respect of the National Council of Sports Act 1964. The SI is yet to be adopted by the Minister of Sports.

14. International Appointments

Donald Rukare of the Uganda Swimming Federation/UOC was appointed to the FINA Masters Committee during the FINA General Congress in Barcelona in July 2013. Mr. Salim Musoke of Uganda Weightlifting Association was appointed as a technical official in the ongoing Islamic Solidarity Games in Indonesia. See full list of international postings on page 19.

15. Participation In International Conferences and Activities

During the reporting period we have taken part in a number of international activities which include;

- German Sports visit 20-29 May 2013. The Federal Republic of Germany and Federal Foreign Office invited the Government of Uganda, Ministry Of Education and Sports (Hon. Charles Bakabulindi, Minister of State for Sports, Mr. Omara Apitah, Commissioner for Sports and Mr. Bosco Onyik, Chairman National Council of Sports) & Olympic Committee (Mr. William Blick UOC President) to visit Germany to study the German sports system. The objective of the visit was to investigate the various sporting systems and how the merger of the German Olympic Committee and their national sporting body merged to create DOSB.
- 1st Olympic Solidarity Quadrennial Forum 2013-2016 Windhoek Namibia. The Olympic Solidarity regional forum was held 6-7 June 2013 and attended by Egypt, Ethiopia, Eritrea, Ghana, Malawi, Kenya, Tanzania, Nigeria, Tanzania, Sudan, Uganda. The IOC solidarity officials from Lausanne and Glasgow 2014 were also in attendance. The event was hosted by the Namibia National Olympic Committee. The primary objective of the forum was to introduce the IOC quadrennial plan 2013-2016
- Association of National Olympic Committees (ANOC) Extra Ordinary General Assembly and Meetings 13-16 June 2013. The President and Secretary General attended the Association

of National Olympic Committees (ANOC) extra-ordinary general assembly from 13-16 June 2013 in Lausanne Switzerland. The IOC president Dr. Jacques Rogge and HW Sheikh Ahmad Al-Fahad Al Sabah President of ANOC addressed the assembly. ANOC now has a new headquarter based in Lausanne. The meeting was held under the theme 'ensuring efficient and effective administration.' The primary objective of the seminar was to seek ways in which national Olympic Committees (NOC's) are managed and run in an efficient and effective manner
- International Conference in Sochi Russia 30th October- 1st November 2013. The Chairperson of the Environment Commission attended.
- Chairperson of the Medical Commission undertook a visit to Germany 17th November 2013.

16. Preparations for International Games.

2014 will see Uganda participate in several regional and international games. The African Youth Games in May 2014, the Commonwealth Games in July/August 2014 and the Youth Olympic Games in August 2014. Preparations have started for these games and will continue into next year. Emphasis this time round is being placed on adequate preparation of the team and transparency in the selection process. We held a consultative meeting with federations/association in October 2013 as part of the preparatory process. An inaugural planning meeting for the commonwealth games was held with the Honourable Minister of Sports.

17. Anti Doping

UOC is committed to drug free sport. To this end, the chair of the medical commission Dr Zavuga was appointed as the Uganda WADA regional representative and it an active participant in this forum. A anti-doping activity work plan has been developed and is being rolled out.

18. Strategic Planning

The UOC executive committee held planning meetings at which they developed an action plan highlighting the key activities and areas of focus for the UOC for the period 2013-2016. The action plan is hinged on both technical and operational objectives. Under the technical we have: (1) athletes





preparation & participation (2) coaches development (3) promotion of Olympic values while under the operational we are looking at: (4)capacity building for sports administrators (5) strengthened the UOC secretariat operations and (6) achieve financial sustainability for UOC operations and programs activities.

19. UOC Planning and Budget Meeting

The UOC executive committee members together with the UOC commission heads held a planning and budget meeting 19-20 December 2013. During the meeting we reviewed discussed the UOC action plan 2013-2016, the 2013 budget, budgets and activities plans from administration/secretariat, technical department and commissions.

20. Hosting of Howard Word Sports and Hospitality

We hosted Howard Schwartz of World Sports and Hospitality Inc. We are exploring the launching of a sports lottery for Rio 2016. Howard is expected in November/December 2013 for the formal launch of the lottery.

21. Court Cases

The UOC and related officials are still subject to 3 court cases. That is, **Jet Tours vs UOC**, **Rio Construction vs UOC and Uganda vs Kabenge**, **Acom and Musoke**. The legal costs associated with these cases is substantial (approx. UGX 25,000,000 as of April 2013) and continues to accumulate. We have discussed this both within the executive committee and with the IOC. We are taking measures to mitigate the costs and the IOC has indicated wiliness to provide support down the road. The **Ddungu vs Blick & others case** was dismissed with costs. UOC lawyers are recovering the costs.

22. Support to National Federation

Within the framework of the UOC several national sports federation that timely presented their needs were considerably assisted to carry out their mandate as the finance report will detail.

23. 2013 IOC Trophy

Each year since 1985, the IOC has launched a trophy with a different theme based on current trends. This trophy is made available to each NOC, which is responsible for identifying and selecting a recipient of the trophy in their territory. This year, the IOC is celebrating the **150th anniversary of the birth of Baron Pierre de Coubertin** and paying tribute to him by naming this year's trophy after him. Following the extensive evaluation and consultation by the UOC merits and awards commission, the UOC executive committee awarded the 2013 IOC trophy to Mr. Gabriel Oloka.

24. Looking to 2014

2014 is going to be a very busy year with three major games taking place. UOC shall focus on ensuring that a well prepared team represents Uganda at each of these games. We shall also place emphasis on finalizing our strategic plan, restructuring the secretariat, review and revision of various operational policies and accessing programs under the Olympic Solidarity programs. We have prepared a 2014 calendar which is annexed herewith for your consideration.
