

As an NOC I am indeed very happy to report that we have effectively carried out our strategic plan objectives. Our 6 strategic pillars have been sucessfully implemented to 80% on average. Capacity building has been to a greater extent been fully implemented after we hit our 1000th graduant having conducted sports management courses across the country and being the first NOC to do so in a refugee settlement (Kiryiandongo refugee camp). Our athletes development program has been accelerated to include more athletes career programs and equal (2) representatives on the board.

There is more funding available from our partners into athletes development. 2018 will indeed go down as a year to remember for the Uganda Olympic Committee and myself as NOC President. I was elected as an IOC Member at the 122nd IOC session in Argentina. To be able to represent the IOC at the highest level is indeed a great honor and privilage. Being the second Ugandan to the Late Major General Francis Nyangweso goes to show Uganda's place at the helm of international sport.





Introduction

This annual report covers the activities implemented during 2018 by the UOC/CGAU in line with its strategic plan. Activities carried out by the various commissions are highlighted as well as the major international games participated.

1. Uoc 2018 General Assembly

We held our Annual General Assembly on 10th February 2018. This was the first time that a joint Uganda Olympic Committee/ Commonwealth Games Association of Uganda (CGAU), Annual General Assembly (AGM) was being held. It was attended by our 25 members together with commission members.

The 2018 member register is reflected in Annex 1 of the report. During the AGM the 2017 annual report, 2018 calendar, 2017 financial report and audit were presented and approved by the assembly.

2. UOC Council Meetings

The council meetings remain a vital space for sharing information between the UOC and its members which promotes accountability, a key of the organizations. In 2018, a total of three council meetings were held attended by all members.

3. UOC Extra Ordinary General Assembly

An extra ordinary general assembly was held on 29th September 2018 at which the proposed revisions to the UOC/CGAU Constitution from the IOC were adopted. The revisions have been approved by IOC.

4. Membership

The UOC membership now stands at twenty (25) member associations/ federations. A full list of the UOC membership is attached as annex B.

5. UOC Secretariat

A. Secretariat operations

The secretariat remained operational and weekly meetings continued to be held. Our administrator, assistant administrator and accountant are all enrolled on professional and management courses aimed at enhancing their capacity to serve the NOC better.

The UOC President William Blick presided over the closing ceremony of the media clinic organized by the

Uganda Swimming Federation on February 17th 2018. The clinic was attended by30 participants from media houses in Uganda and was aimed at enhancing the knowledge of the media to report on aquatic from an informed point of view. The Uganda Handball Federation hosted the Zone five, Youth and Junior Handball Championships in May 15-20 2018 at Namboole Stadium.

10. Participation in international games.

Team Uganda participated in the Commonwealth Games 4-15 April 2018 in the Gold Coast Australia, Team Uganda comprised of 69 athletes (31 female – 38 males) attended the games assisted by 34 technical officials. In addition officials from the Commonwealth Games Association Uganda, National Council of Sports, Ministry of Education and Sports and CGAU guests attended the games. Uganda fielded teams in eleven sport codes which included, Athletics, boxing, swimming, squash, shooting, table tennis, badminton, weightlifting, cycling, netball and ruby sevens.

Team Uganda registered notably performances in athletics and boxing winning six medals (3 Gold, I sliver and 2 bronze).² In addition the she cranes put up a commendable performance qualifying for the world cup after getting 6th place overall during the games. Several members of team Uganda posted personal and season's best's as well national records in their respective events. Overall the team spirit and discipline was good though two weightlifters were absent with leave and are believed to in Australia which is rather regrettable. Team Uganda emerged overall 15 out of 71 countries and number 4 in Africa which is very commendable.³

The African Youth Games took place in Algiers Algeria between 17-28 July 2018. Team Uganda field 32 athletes (24 male, 8 female) in Rowing, Athletics, Weightlifting, Badminton, Swimming and Handball. 16 officials (12male, 4 female) accompanied the team. See table 1 below. They have so far put up a very commendable performance winning three silver medals (3000m female track- Sarah Chelangati, Badminton Men's Singles- Brian Kasirye, Oscar Chelimo-3000m track and Swimming 50m Butterfly women – Rebecca Ssengozi). Several athletes attained the Youth Olympic Games qualification times during the games. The games are due to end on 28th July 2018 and the team returns on 30th July 2018. A complete report on the games will be provided by the Chef de Mission.

The opening ceremony was held in the streets of Buenos Aires which was a break from the traditional of holding the ceremony in a stadium. Uganda entered a team of 5 athletes (3 females and 2 males) from Athletics (3), weightlifting (1) and rowing (1). Team Uganda won gold/bronze medals by Chelangat Sarah and Chelimo Oscar respectively.

11. CGF Activities

The equip intern, Deborah
Namusoke supported the
preparation for Commonwealth
Games 2018 Gold Coast and
concluded her tenure in September
2018. She attended the final equip
evaluation workshop in London UK,
27-28 July 2018. A new equip intern
Sheila Arinda is now onboard.

CGAU was represented at the CGF General Assembly in Gold Coast Australia, on 31 March 2018 by Vice President Beatrice Ayikoru and Executive Committee member Moses Mwase.

12. The UOC Intern Program

During 2018 we took on three interns under the UOC internship program. The three interns from Kyambogo University spent 4 months with the UOC and were exposed to the various facets of sports management and organization. We also have taken on a Commonwealth Equip intern to assist with Commonwealth related matters.

13. Capacity building

Annette Nakamya successfully completed the MEMOS program in September 2018.



We are awaiting the outcome.


18. UOC /CGAU Annual Retreat


The Uganda Olympic Committee (UOC) and Commonwealth Games Association of Uganda (CGAU)

19. Draft Physical Activity and Sports Bill 2017

The Ministry of Education and Sports (MOES) is yet to finalize the draft Physical Education and Sports Bill 2017. The proposed Act seeks to provide for the National Council of Sports, establishment of a sports development fund, establishment of the Uganda Sports Institute, administration and management of sports in the country, to provide for all aspects of physical activity and sports, including individual and mass physical activity, physical education, organized and informal sports, competitive and noncompetitive sports, health club activity, professional sports and any other emerging form of physical activity or sports, repeal the National Council of Sports Act Cap 48 and for any other related matters.. We have submitted consolidated views and comments on the bill from members with MOES and the UOC met with the drafting team in August.

20. UOC Constitutional Review Process

The UOC Constitutional Review Commission following appointment by the UOC Executive Committee commenced its work in August. The review commission has held several meetings as well as a consultative meeting on 14th August 2017 with UOC members at which views and proposals on various constitutional amendments were made. Further consultation with members will be done during the UOC Council held on 9th September 2017. An Extra Ordinary Assembly to consider and adopt constitutional amendments was held on 16th September 2017 at the UOC. The revised constitution which was forwarded to the IOC is

still pending approval. The National Council of Sports and Ministry of Education and Sports are also yet to provide their position on the revised constitution which was forwarded to them.

21. Governance and compliance session UOC/CGAU members

We held a Governance and Compliance Session for our members on August 4th 2018 at the UOC. The session drew participants from national sports federations affiliated to the UOC/ CGAU as well as UOC/CGAU executive committee members. The topics covered during the session included a number of areas such as the monitoring and evaluation process of the National Council of Sports (NCS), understanding your constitution, common governance sports hotspots and basic financial management practices. Discussions including question and answer sessions were held in which participants identified/ shared several governance and compliance challenges facing national sports federations. A final evaluation of the session was undertaken which revealed that over 95% of the participant found the seminar very good and valuable to their work. Several recommendations are made in respect to future sessions; top on the list was the need to hold the sessions more regularly and as well as including government officials from NCS and the Ministry of Education and Sports.

22. Olympic Solidarity Audit/financial review – PWC

The IOC instructed PWC to carry out a financial review/audit of selected activities funded by the Olympic

Solidarity for the period 2015-2016. Their final report was presented to the Executive Committee. Overall the findings of the report were positive.

23. 2018 Audit

The 2018 audit was finalized by our auditors FCK Auditors. The audit report has been circulated to members and will be presented during the 2019 Annual General Assembly in February 2019.

24. Admission of new members

The International Olympic
Committee (IOC) instructed that
we (UOC) should admit baseball/
softball, Karate, skateboarding, sport
climbing, and surfing in advance
of the Tokyo 2020 Olympics. These
five's continued membership post
Tokyo 2020 will depend whether
they remain Olympic sports for next
Olympics in 2024.We also have a
few other Olympic sports that are
not UOC members like Golf, Modern
Pentathlon and Judo.

Following receipt and review of an application from the Uganda Baseball and Softball Association (UBSA), the Executive Committee granted temporary/provisional membership to Uganda Baseball and Softball Association. Their full membership will be considered in the next UOC AGM. We have received applications for membership from:

- Uganda Judo Federation
- Uganda Golf Union
- Uganda Modern Pentathlon Federation
- Uganda Lacrosse Association

UOC will consider applications from other potential members as and when we receive them.

25. 2019 Calendar

2019 is going to be an active year with the several commission activities, the All African Games, the African Beach Games and World Beach Games. The qualification pathway for the Tokyo 2020 Games begins in 2019. A copy of the calendar is in annex 3.

26. Conclusion

We shall focus on the following (1) continue to prepare for international games i.e. African Games Morocco, African Beach Games Cape Verde and World Beach Games San Diego USA (2) continue implementation

of the 2017-2020 Olympiad Plan (3) hold a retreat for the UOC Executive Committee and (4) Hold the UOC AGM (5) hold a planning and budgeting session for 2019 (6) Prepare to host the IOC President Dr. Thomas Bach((7) hold the Annual General Assembly (AGM) (8) Celebrate 65 years of the existence of the UOC. he UOC/CGAU and secretariat remains at the service of the UOC/CGA family and we believe that working hand in hand we shall further develop sports in Uganda.


