PRESIDENT'S REMARKS

I have the great honour and pleasure to bring you our annual report for 2019. We had an excellent year as we prepared for Tokyo 2020.

For the first time we have had an excellent talent identification pathway which has enabled us to support our best athletes to be the best in the world. Under the IOC athletes support program Joshua Cheptegei became a double world champion (World Cross country and 10,000M) while Halima Nakaayi became 800m women world champion closely followed by Winnie Nanyondo who finished 4th. Ronald Musagala also won two Diamond league events making him one of the favourites for the men's 800m final. The 2019 World Championships in Doha were by far our best ever performance bringing home two gold medals.

For the first time in our history we qualified an Olympic rower. Grace Noble Kathleen became the first ever rower to qualify for the Tokyo 2020 Olympic games. Kathleen made the grade after racing the 2KM race in the single scull category during the Africa Rowing regatta held at Lake Tunis in Tunisia. As we approach the end of the Tokyo 2020 qualifications, we aim to qualify our biggest contingent of 35 athletes. After finishing 8th at the World Athletics championships I believe it is a good omen and sign of good things to come for Tokyo 2020! Boxing has been administratively stabilised and has started to produce some results winning 3 medals at the All Africa Games in Rabat (Hellen

Baleke - Bronze in 75kg Female Middle Weight, Isaac Masembe -Silver in 57kg Feather Weight and David K. Ssemujju - Silver in 75kg middle weight- Boxing).

The promotion of Olympic values programs have been growing from strength to strength all over the country. Our annual Schools literacy and debate championships have attracted a record number of schools making our event the biggest national schools' debate. The sustainability and environment commission has been promoting environmental protection in Eastern Uganda. The capacity building initiatives have for the first time been conducted in all regions of Uganda greatly contributing to the development of our sports administrators in the country now exceeded 1200 students in the last seven years and counting.

Our diplomatic partnerships with the Italian and French Embassies have enabled us to diversify our focus to take on sport for social development projects. Our partnership with the French Embassy "Uganda France Friendship week" remains the biggest event for the embassy signalling the power of sport and its importance in the French diplomatic strategies as they prepare to host the Olympics in 2024. The proceeds from our event are currently used to construct 2 all-weather hard courts for two disadvantaged schools. With the Italian embassy we were able to partner with UNHCR, ACAV and Sampdoria FC to take football and Olympic values to 5 refugee settlements giving the youth an opportunity to have world class football training from the Sampdoria coaches. This life changing experience had a football match and coaching sessions for the coaches and the youth. An introductory sports management class was conducted. In 2020 we plan to follow up this initiative with the support of the Olympic Refuge foundation a three-year project in partnership with UNHCR, Italian Embassy and the Office of The Prime Minister. This unique coalition paved way for the signing of an MOU with CONI (Italian National Olympic Committee. We plan to capitalise on the Cortina 2026 Olympic legacy Program to hopefully qualify our first ever winter Olympic athlete.

As we wind up our second quadrennial, we will review our strategic plan signalling the end to my final term as NOC President. It has been an honour to serve Ugandan sports at an international sporting level having been elected to the highest office of sport in the world as an IOC Member. My election was the greatest my honour and reward I could ever be given. I sincerely thank Dr. Thomas Bach President of the International Olympic Committee for this recognition and believing in me as an individual. A big thank you also goes out to the UOC Executive, member federations and the National Council of Sports for all their support in 2019.

SECRETARY GENERAL'S REMARKS

2019 was a vibrant year with several activities undertaken at the Uganda Olympic Committee (UOC) / Commonwealth Games Association of Uganda (CGAU). We were able to achieve 95% of our planned activities during the year. Our

commissions remained very active and were at the heart of promoting olympism across the country. In this regard we held several activities that

are highlighted in this report.

Uganda featured at several major regional and international championships which included the 1st African Beach Games in Cape Verde, the Africa Games in Morocco and the inaugural World Beach Games in Doha Qatar. Team Uganda posted very impressive podium performances at the games and continued to fortify its position as an emerging sporting country. In addition the UOC/CGAU attended a number of regional and international forums through which we inter alia explored collaborative networks. To this end for example we are looking to concluding memorandum of understanding with the national Olympic committees of Qatar and Italy.

Uganda continues to be one of the regional destinations for major conferences

and seminar in line with one of our strategic areas of focus. We hosted the 3rd International Sports Law Seminar for African NOCs this year. The training seminar was supported by the Olympic Solidarity (OS) and the UOC. 43 participants including 22 from the rest of Africa attended the seminar. The 3rd International Sports Law builds on the previous two seminars held in 2016 and 2017 respectively. The primary objective of the training was to build the capacity of African/ Ugandan NOCs/ National Federation lawyers in the area of sports law through enhancing their knowledge on the subject. The Kampala Declaration on Sports Law in Africa 2019 was adopted at the end of the seminar calling for inter alia the creation of regional sports dispute mechanism. The creation of this mechanism is something we firmly intend to purse going forward.

We remain firmly committed to building the capacity of our sports administrators. In this regard as highlighted in this report several individuals drawn from the UOC secretariat and national federations/associations have attended or are pursing sports administrators courses (SAC), advanced management courses (ASMC), diplomas and Masters Programs nationally and abroad. We shall purposefully continue support these programs as we believe that empowered sports administrators are critical to rising the sporting tide in the country.

2020 is an Olympic year with all sporting roads leading to Tokyo Japan in July. We are targeting to have a team of 35-40 athletes in Tokyo next year. Preparations are in advanced stages and we look forward to our team putting its best foot forward at the games.

EXECUTIVE SUMMARY

The report outlines the main activities of the UOC/CGAU carried in 2019 which include, the operations of the UOC secretariat, update on programs under the Olympic Solidarity program, interaction with member national federations/ associations, collaboration linkages with strategic partners, international appointments, participation in international and regional conferences, preparation and participation in various international games, anti-doping and strategic planning for the UOC/CGAU.

The UOC commissions were very vibrant and to this end implemented several activities aimed at promoting Olympic values and education across the country.

UOC continued to deepen its footprint on the international scene as illustrated in the various mentioned and highlighted activities in this report. Hosting the 3rd International Sports Law Seminar was one of the key highlights of the year. The report concludes by looking ahead to 2020 which will have the Tokyo 2020 Olympic Games as the main sporting attraction. It is envisaged that between 30-40 athletes will participate in the games. So far 15 have qualified for the games next year. Our member federations will endeavor to qualify additional athletes in various games during the course of 2020. The UOC executive committee remains resolved to strive for excellence and ensuring that the best interest of the athletes remains central to our mission and work.




Durring the year the CGAU carried out a number of activities that included:

operation and management of the program to ensure that it is run optimally, effectively and efficiently.

1.9. OLYmpians Recognized

On the 21st of December 2019, Ugandan Olympians from all generations(1964 - 2016) came together for the first time. It was an exciting and emotional reunion as some had not met each for almost fifty years. OLY Certificates and Badges were issued. It was agreed that they would meet every six months with the aim of addressing issues such as: Athletes' Mental Health. Athlete Career Programme and Economic Empowerment of athletes after sport. The UOC remains firmly committed to supporting the association and its activities.

1.10. UOC Constitutional Review Process

Following highly participatory review process, the UOC/CGAU constitution was amended in 2018. The amended constitution was adopted by the UOC/CGAU and approced by the IOC.

1.11. Admission of new members

The UOC/CGAU is proud to welcome five new members to the family. This brings our total number of members to 30. We look forward to closely working with the new members that include:

- → Uganda Golf Union
- → Uganda Modern Pentathlon

1.12. 2018 Audit

The 2018 audit has been finalized by our auditors FCK Auditors. The audit was presented to the Annual General Assembly on 23 February 2019.

1.14. Hosting the 3rd International Sports Law Seminar 31 May – 2 June 2019

The Uganda Olympic Committee (UOC) in conjunction with ISDE Law and Business School based in Madrid Spain held the 3rd International Sports Law training seminar in Kampala 31 May to 2 June 2019. The training seminar was supported by the Olympic Solidarity (OS) and the UOC. 43 participants including 22 from the rest of Africa attended


the seminar. The 3rd International Sports Law builds on the previous two seminars held in 2016 and 2017 respectively. The primary objective of the training was to build the capacity of African/ Ugandan NOCs/ National Federation lawyers in the area of sports law through enhancing their knowledge on the subject. The Kampala Declaration on Sports Law in Africa 2019 was adopted at the end of the seminar calling for inter alia the creation of regional sports dispute mechanism.

1.15. National Sports Forum 28th May 2019

The Honorable Minister of State for Sports Charles Bakkabulindi convened a national sports forum on 28th May 2019. The forum was attended by representatives from the National Council of Sports and leaders of National Sports federations/ associations. During the forum several issues related to sports development in Uganda were discussed which included, limited funding, lack of adequate human resource capacity, poor communication channels between MOES/NCS and federations, lack of a funding policy and clarity on how the eight priority sports were selected, lack of facilities, taxes on sports equipment and lack of offices/ staff for federation. Some of the recommendations arising from the forum were the need to increase funding to federations as well as determining a minimum funding package for each federation. A follow up forum is planned.

1.16. Partnerships and Networking

The UOC enjoys a cordial relationship with the National Council of Sports and the Ministry of Education and Sports. The General Secretary of the National Council of Sports Dr. Patrick Ogwero states; In the contemporary world, there is no universal definition

of 'Sport' since Sport is always evolving, and there is an increasing merger of Entertainment and Sport which has prompted the Olympic Movement to introduce new disciplines that are oriented towards increasing youth participation, among others.

It is important for an aspiring Sports Nation with a lot of potential like Uganda to regulate Sports and facilitate the fastracking of the development - Fastracking the sports industry and its growth is therefore, no longer an option but a priority. There is need to strengthen Sport Governance in order to deliver value to the Athlete, the potential Athlete, the Fan and the Public and all of those virtues that are embedded in the broader concept of National interest and sustainable development - this is why NCS (government) has to pick its niche priorities especially, when it comes to use of the National Flag and National interest of the Citizens.

Altogether, we shall learn from the unifying power of Sport and find ways

to use it as a unique tool to bridge the gaps that divide us both across and within societies but also use Sport to strengthen our socio-economic aspirations.

Special attention and focus will now be geared towards providing better policy and legal frameworks to facilitate and streamline the growing need of regulating and advancing Sports in the Sports Sub-sector, in a bid to protect interests of all the respective Stakeholders, and other partnerships across the wider spectrum.

In conclusion, I wish to thank the Uganda Olympic Committee for the unreserved effort in sports development in Uganda and am counting on the sincere cooperation of all other interested stakeholders to closely work together for a common cause of realising our national objectives and providing a better platform for the promotion and development of Sports in Uganda.

1.18. International Coaching Practices; Japanese Perspectives training 10-11 August 2019

The Uganda Olympic Committee (UOC) in conjunction with Tsukuba University/ Tsukuba International Academy for Sports Studies (TIAS) held an International Coaching

This was a follow up from a meeting held between Prof Randeep, UOC President William F. Blick and UOC Secretary General Donald Rukare during the ANOC General Assembly in Tokyo in November 2018.

1.19. Anti-doping activities

The UOC Executive Committee appointed Dr. Aya Nakitanda to head the National Anti-Doping Organization (NADO) and represent Uganda on the Board of the Regional Anti-doping Organization (RADO). She is supported by Mr. Christopher Mbowa, RADO educator and Mr. Christopher Oluk, RADO Senior

Doping Control Officer (DCO). The role of the NADO is to maintain Uganda's compliance to the World Anti-Doping Code through policy, testing and education. In 2019, the team engaged with various NFs for educational programmes and national team preparations to ensure athletes and athlete support personnel were aware of and prepared for doping control procedures at local/international events. These included seminars for IAAF world championships, ANOC world beach games bound teams as well as an outreach at the AUUS national university games, among others. Both in-competition and outof-competition tests were conducted, and attest the low doping risk in Uganda, which status the team is working to maintain. In the coming year, the UOC will launch an antidoping section on the new website with essential resources to keep stakeholders up to date and informed on all matters relating to doping.

1.20. Athletics for Development Program

The Uganda Olympic Committee (UOC), and its' member National Federations (NFs) overwhelmingly welcomed the 'Athletics for Development' (A4D) Project of the German Development Cooperation (GIZ) and the German Sports Confederation (DOSB). Uniquely about the Project is its focus on using the Athletic skills of running, jumping and throwing to an instrument for development, promoting civic participation, social cohesion, intercultural learning, conveying of values, and realization of the UN Sustainable Development Goals (SDGs).

The UOC appointed a Liaison Officer, Mr. Isima Iga who is responsible for the coordination of the project with the UOC annual programs. A summary of the activities done in 2019 is listed below:

Contribution to the A4D Manual production which details various sports drills aimed at life skills development with communities.

The signing of the Contract between the UOC and the GIZ Uganda pertaining to the implementation of six (6) Projects of the TRN under the GIZ Local Subsidy
